As a guide for its work, the Board assesses conditions and needs of historical records programs in the state and establishes funding priorities.

QUALIFICATIONS:   Members of the board shall be appointed by the Governor. The majority of the members must have recognized experience in the administration of government records, historical records or archives.

The panel shall make recommendations to the Legislature, to the Department of Education, to charter schools, and to school districts for improving charter school operations and oversight and for ensuring best business practices at and fair business relationships with charter schools.

QUALIFICATIONS:            The panel shall include 3 members appointed by the Governor, 2 appointees each from the Commissioner of Education, the President of the Senate, and the Speaker of the House. Members shall have experience in finance, administration, law, education, and school governance.
